**Relief measures to MSME/Industries affected by Natural calamities
(Hydrological Drought) in 22 Districts of Tamil Nadu
Time extension up to 05.12.2024**

G.O.(Ms) No.111 dated 13.03.2024, has been issued by Revenue and Disaster Management Department, Disaster Management Wing, D.M. III (1) Section, GoTN regarding Hydrological Drought in 22 districts of Tamil Nadu.

The above was placed as an Agenda in the 178th SLBC meeting and sub- committee, which was formed for the purpose, deliberated and approved the relief measures. The relief measure was also approved by Reserve Bank of India. The timeline for restructuring was within three months from the date of intimation received from GoTN i.e., up to 05.09.2024.

Further we have received representation from Banks on 09.09.2024 to extend the time limit for another 3 months since the earlier time limit given was only up to 05.09.2024. The same was taken up with RBI for extension by SLBC on 11.09.2024. We have received permission from RBI dated 24.09.2024, permitting for extension of time frame up to 05.12.2024 for implementing the relief measures to Hydrological Drought in all the blocks of 22 districts of Tamil Nadu as given below.
